



CELL PHONE POLICY

The school management as well as the governing body of Dunatos Remedial School had a consultation with the staff and took the following decisions. This document thus becomes an internal policy document that will be contained in the prospectus and code of conduct. The teachers will also discuss this with their students.

PRINCIPALS :

- During an official school day from 7:57 – 14:15 no student is allowed to have their cell phones switched on during any classroom or teaching situation. Students are also not allowed to be busy on their cell phones in any way before school on the school grounds. If a student is caught in violation of the rule, the student must hand over their cell phone to the monitoring / supervising teacher. The cell phone will be kept in safe storage for the following periods:
 - First violation for 5 school days
 - Second violation for 10 school days
 - Third violation for 15 school days
- The cell phone can be collected at the office after the safe keeping period ends by the parent / guardian at the end of the school day, (for the period that the cell phone is taken away it will be locked in the school safe for safe keeping.) This will be treated as a Grade 1 violation of the code of conduct.
- In the case that the student is using the cell phone in an assessment period (exams, standard test) their cell phone must be handed over to the teacher involved. This will be treated as a Grade 2 violation of the code of conduct. The cell phone can be fetched at the end of the term by a parent / guardian only at the office.
- In the case of the student bringing a cell phone to school, we cannot be held responsible for it. Bringing a cell phone to school is solely the responsibility of the student involved. A cell phone may not be kept or carried in a bag / holder on the student's waistband either. Students are welcome, but not obligated to hand in their cell phones in admin period to their register teacher for safe keeping to being locked in a safe or cabinet.
- In case a parent / guardian has an emergency or message to be communicated to a student during an official school day it will be treated the same as it generally would. All calls must be made to the office, which we will then inform the learner concerned accordingly.
- Students may also not use a cell phone or public telephone during class times. In the case of an emergency, the students involved can make a call at the office.
- The school can also not take responsibility for any cell phones after the official school day (referencing to any times students part take in activities or sport.

WHY DO WE NOT WANT CHILDREN TO USE CELL PHONES AT SCHOOL :

1. The school has a telephone at reception. If a child has to contact a parent urgently, it can be done by the office.
2. The safety aspect: Primary school-, High school- and Lsen students make easy targets to criminal elements that wants to steal the cell phone.
3. Financial implication on the parent / guardian: To replace a stolen cell phone is very expensive. The school can also not take responsibility for the cell phones.
4. See the above with regards to learners who use cell phones during class
5. Safe keeping of all the phones at the school: Logistically, it is not possible to keep and manage all cell phones at the school.
6. Cell phones are often the "instrument" that student use to bully other students.
7. Some learners are not yet mature enough to use it responsibly and can prevent cases of pornography and sexual harassment.
